

2009 End-User Printer Trade-In Program

Receive rebates when you trade in equipment and make eligible purchases of Intermec printers between March 2 and June 30, 2009.

How it works

1. Trade in either an Intermec or competitive printer and purchase a qualifying Intermec printer between March 2, 2009 and June 30, 2009. Your rebate will be based on a 1:1 ratio of eligible units you trade-in to the eligible new units you purchase (see the following page for details). Purchases must be made from an Intermec authorized source.
2. Fax a copy of your invoice (i.e., proof of purchase) for your new Intermec equipment and a rebate coupon to Intermec Rebate Processing at 905.673.3974.
3. Upon receipt of your rebate coupon and invoice, Intermec will email you a confirmation along with detailed instructions for shipping your trade-in equipment.
4. Once the rebate coupon, invoice and trade-in equipment have been received (at the location instructed in the email), a rebate check will be issued to the product end user. The total amount of the rebate depends on the unit(s) traded in, as well as the new products purchased.
5. Shipments of trade-in equipment must be postmarked within 30 days of invoice for the new Intermec equipment. Example: if the new Intermec equipment has an invoice date of April 1, 2009, the trade-in equipment must be shipped no later than May 1, 2009.
6. All trade-in equipment must be received by Intermec no later than July 31, 2009 in order to be eligible. Any exceptions must be requested in writing prior to July 17, 2009.
